## SUMMER CAMP 2025 - Suggested Kit list for Scouts

The following is a reasonable guide for a Scouts camp kit:

- Top Half Uniform, to be worn to and from camp.
- **Packed Lunch for Sunday.**
- Rucksack or Large bag.
- Light day bag for the trip out
- Sleeping bag
- Blanket
- Roll mat (for sleeping on). **No camp beds or air mattresses please they take up too much space.**
- Pyjamas or a track suit for sleeping in only.
- Waterproof outer garments.
- Hat (warm and sun).
- WARM sweaters.
- T-shirts or similar.
- Shorts/Trousers.
- Underclothes (enough for every day + a couple of spares).
- Socks (enough for every day + a couple of spares).
- Shoes which can get wet and a change of clothes for kayaking and rafting (they might want two sets as we are doing both on the same day)
- Trainers
- Personal washing gear.
- Towels.
- Tea towel.
- Tissues.
- Notepad and pencil/pen.
- Torch plus spare bulb, batteries etc.
- Sun block (factor 20+ minimum).
- Small personal water bottle – named please.

NB: There is a walk from the car park to the camp site. Make sure you can carry your bag.

Pocket knives may be brought to camp but must be handed in to a leader on arrival and will be held centrally until needed.

Scouts may bring a mobile phone to camp. These must be handed in to a leader and can be requested as desired (within reason and safety), there will not be any way to charge them at camp, power banks can also be brought and should also be handed in as they pose a hazard in hot tents.

Scouts may bring activities to do in their free time, we recommend that they do not bring anything they are worried about getting damaged – tents can get pretty wet and muddy and Scouts do often stand on things.

There is a small tuck shop on site, and we will be visiting London on Wednesday so Scouts can bring pocket money or card with them to spend if they want to. This should be handed to a leader. We recommend that they do not bring more than £25.

All food will be provided and there is plenty of it. However, we know that some Scouts feel more comfortable if they pack some snacks from home. If they choose to bring snacks, we recommend bringing things that do not need to be kept cool and an airtight box to keep them in so that they do not attract vermin to their tents.

### \*This means:

Section 21 prohibits the possession of a firearm and ammunition (under any circumstances), by any person who has been convicted of a crime and sentenced to a term of imprisonment (or its equivalent for young persons) of 3 months or more. The prohibition applies in all circumstances, including handling and firing at an approved shooting club or at a clay pigeon shoot where a certificate is not ordinarily required. It also applies to the possession or use of any other categories of firearms and ammunition such as **AIRGUNS** or shot cartridges for which a certificate is not needed.

A sentence of 3 months to 3 years attracts a 5 year prohibition, shorter ones no prohibition but a longer one means a life ban.
